

Administrator Report

In March of 2014, the Commonwealth Coordinated Care program was introduced and made available for recipients who are over the age of 21 and who are eligible for both full Medicare and Medicaid benefits. During this phase, eligible recipients received information on the Commonwealth Coordinated Care program and were able to voluntarily enroll in the program, with coverage beginning on April 1, 2014. For those who meet the eligibility criteria and who did not opt out of the Commonwealth Coordinated Care program, in June 2014, Phase 2 was implemented where individuals are being automatically enrolled. Their coverage will be initiated on September 1, 2014.

Please be aware, that everyone does have a choice. They can opt in or opt out at any time.

Under the Commonwealth Coordinated Care (CCC) Program the Medicare Medicaid Plans (MMPs), Virginia has contracted with Anthem Healthkeepers, Humana, and Virginia Premier to coordinate the services for those who choose to participate.

Personal Touch Home Care Services, Inc., Moore Home Care Services, Inc., and Southern Touch Health Care Services, Inc. are participating providers in all of the Medicare-Medicaid Plans (MMPs) For those who choose to enroll with the MMPs, all of their existing plans of care will be honored until the authorizations end or 180 days after their enrollment date, whichever is sooner. After this period of time, a Case Manager from the MMP's will determine what services you will receive and how many hours you will receive.

The Department of Medical Assistance Services (DMAS) states the goals of this program are: improved quality and health outcomes, streamlined Medicare and Medicaid requirements, increased accountability, reduced burden for enrollees and providers, providing care in each individual's setting of choice, and reduced avoidable services." At this point, it is difficult for me to give my opinion on the program. Admittedly, there have been issues with getting authorization confirmations as well as in the billing process and there remains an uncertainty of what actually will occur when current authorizations expire. However, we want everyone to know, that we remain committed to all of our clients and will continue to strive to meet your needs and to deliver the quality of care each deserves.

Keep Your Cool in Hot Weather


Learn about heat-related illness and how to stay cool and safe in hot weather.

Getting too hot can make you sick. You can become ill from the heat if your body can't compensate for it and properly cool you off. Heat exposure can even kill you: it caused 7,233 heat-related deaths in the United States from 1999 to 2009.



Main things affecting your body's ability to cool itself during extremely hot weather:

- High humidity. When the humidity is high, sweat won't evaporate as quickly, which keeps
 your body from releasing heat as fast as it may need to.
- Personal factors. Age, obesity, fever, dehydration, heart disease, mental illness, poor circulation, sunburn, and prescription drug and alcohol use can play a role in whether a person can cool off enough in very hot weather.



People at greatest risk for heat-related illness can take the following protective actions to prevent illness or death:

- People who are at highest risk are the elderly, the very young, and people with chronic diseases or mental illness.
- Even young and healthy people can get sick from the heat if they participate in strenuous physical activities during hot weather.
- Air-conditioning is the number one protective factor against heat-related illness and death. If
 a home is not air-conditioned, people can reduce their risk for heat-related illness by spending
 time in public facilities that are air-conditioned.



Take these steps to prevent heat-related illnesses, injuries, and deaths during hot weather:

- Stay in an air-conditioned indoor location as much as possible.
- Drink plenty of fluids even if you don't feel thirsty.
- Schedule outdoor activities carefully.
 - o Wear loose, lightweight, light-colored clothing and sunscreen.
 - o Pace yourself.
- Take cool showers or baths to cool down.
- Check on a friend or neighbor and have someone do the same for you.
- Do not leave children or pets in cars.
- Check the local news for health and safety updates.
